WIOV-FM'S "LUKE COMBS TEXT TO WIN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WIOV-FM ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.wiov.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WIOV-FM's "Luke Combs Text to Win"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. How to Enter. Opt-in to the WIOV Text Club by sending a text message with the keyword WIOV spelled correctly to 800-860-1105 before the start of the Contest Period. On or about 10:00 a.m. ET on July 25, 2023, all opted-in members of the WIOV Text Club will receive a text message containing the secret keyword. Members must text that secret keyword back to the Station at 800-860-1105 during the Contest Period to be entered in the contest. All entries must be received by 11:45 a.m. ET on July 25, 2023 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 4. Winner Selection. On or about 11:45 a.m. ET on July 25, 2023, Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
