WIOV-FM's "GEORGE STRAIT TICKET GIVEAWAY APRIL 28 – MAY 2, 2025" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WIOV-FM ("Station"), 2300 Vartan Way, Suite 130, Harrisburg, PA 17110, during available business hours Monday through Friday, on the Station website www.wiov.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WIOV-FM's "George Strait Ticket Giveaway April 28 – May 2, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. - 2. Contest Period. The Contest entry period will begin at 5:00am ET on April 28, 2025 and will run weekdays from 5:00am ET until 10:00am ET through 10:00am ET on May 2, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. When the Station gives a cue to call, listeners must call the Station at 800-860-1105. Caller #9 to the Station, as determined by the Station in its sole discretion, will be eligible to participate in the contest. The caller will be asked trivia question(s). If the caller answers correctly, they will be eligible to win after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If the caller answers incorrectly, the Station will take the next caller and repeat the contest until a winner is found. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast*: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.
